Criteria for all student members:

- Must be attending a post secondary institution, in first year or above (ie. not in high school)
- Must have attended at least 3 meetings (MEMO 2017 M4S volunteer qualifies) during the 2017-2018 CIM term between September 2017 and January 2018. Higher attendance given preference.
- Undergraduate students may receive this award only once every two years, even if in graduating year. They may not be on internship at the time of the application. They may receive the scholarship twice during their undergraduate degree.
- Graduate students may receive this award only once for each post graduate degree.
- All student applicants must be CIM National Student members (join at http://cim.org/).

Submission requirements:

You will be expected to submit a letter with your application, describing:

- Why you deserve this award.
- Your education to date, awards, community services, participation in sports, music or the arts, career aspirations
- Other relevant information (include a discussion of your involvement in the CIM Saskatoon Branch, and/or the mining community, as appropriate. Please omit direct references to your name and/or the name of your parents in this letter).
- Unofficial transcript

Student marks are not the main measure for the scholarship selection, but we require you to submit transcripts (unofficial is acceptable) showing your marks for the 2016-2017 academic year.

This application, and copy of your letter and transcript of marks, must be received by CIM Saskatoon Executives no later than Thursday February 1st, 2018. The application is to be e-mailed to the Branch at cimsaskatoon@gmail.com with the subject line, "Attention Scholarship Committee".

You will be emailed a confirmation-of-receipt of your application. It is your responsibility to follow-up with the CIM Saskatoon Branch, by February 5th at noon, if you did not receive that confirmation email. After February 5th at noon, entry to the scholarship evaluation process is closed. If your application was not received and you did not follow-up by noon on February 5th, we encourage you to apply in future years.

Declaration by applicant and parent:

I understand and agree that:

- Applicants who did not receive an email from the CIM Saskatoon Branch to confirm that the application was received are not eligible for the 2017-2018 scholarship.
- The CIM Saskatoon Branch Scholarship Selection Committee decisions are final and binding.
